

## **Key Criteria to Apply – Raters/Providers**

Verified at least 100 ENERGY STAR certified homes during 2018 (as either a Home Energy Rater, Accredited Rating Provider, or Quality Assurance Provider).







## **Key Changes- Raters/Providers**

- The builder no longer simply nominates the Rater/Provider for an award. The Rater/Provider will need to complete an application.
- New categories and scoring:
  - Promoting ENERGY STAR Recruitment and Retention
  - Assisting Builders in Meeting ENERGY STAR Program Requirements
  - Assisting Builders with Homebuyer Education
  - Implementing Innovative Quality Assurance Approaches
  - Demonstrating Industry Leadership with ENERGY STAR (Bonus)







## Examples have been provided throughout to assist.

### **Promoting ENERGY STAR Recruitment and Retention**

Example - Worked with ABC Builder to increase their percentage of ENERGY STAR certified homes from 50% to 75%, representing a difference of 700 additional certified homes in 2018.

### Implementing Innovative Quality Assurance Approaches

Example – Developed a new technology solution to streamline our ENERGY STAR inspection and reporting process through a handheld, cloud-based platform.

## **Key Criteria to Apply – New Home Builder**

- Formally committed (in MESA, <u>www.energystar.gov/mesa</u>) to building 100% of their homes to meet ENERGY STAR program requirements in 2018.
- Constructed at least 50 homes (for market rate home builders) or at least 25 homes (for affordable/low-income housing builders) earning ENERGY STAR certification during the 2018 calendar year.

  - Educating Homebuyers

#### Award Description

The Partner of the Year and Sustained Excellence awards for Home Energy Raters/Providers recognize partners that have demonstrated excellence and innovation in expanding the market for ENERGY STAR certified homes.

#### Eligibility Requirements:

To be eligible for recognition, applicants must meet each of the following requirements:

- Verified at least 100 ENERGY STAR certified homes during 2018 (as either a Home Energy Rater, Accredited Rating Provider, or Quality Assurance Provider)<sup>1</sup>;
- . Maintained active ENERGY STAR partnership in good standing for at least one full year;
- Maintained satisfactory compliance with all applicable EPA regulations (EPA will perform a compliance/enforcement screening for each applicant as part of the application review process); and
- Maintained good standing (e.g., no active or pending disciplinary actions, probations, or suspensions) with their Verification Oversight Organization (e.g., Residential Energy Services Network/RESNET).


To be eligible for a Sustained Excellence award, applicants must meet the above requirements AND have received a Sustained Excellence award the previous year or received a Partner of the Year award each of the past two years. Applicants meeting these requirements will be automatically considered for a Sustained Excellence award.

#### Application Instructions

ALL application materials must be submitted electronically through My ENERGY STAR Account (MESA) (<a href="https://www.energystar.gov/mesa">www.energystar.gov/mesa</a>) using the electronic application forms provided. These materials must include:

- PART 1: General Instructions & Executive Summary which includes a brief description of your
  organization and six bullet points showcasing your organization's main ENERGY STAR certified homes
  achievements during 2018 in the corresponding fields. (required)
- PART 2: Award Accomplishments Document consists of your organization's responses to Sections A
  and B of this application. (required)
- PART 3: Supporting Materials include electronic samples of materials used by your organization (e.g., samples of 2018 marketing and training materials) in support of the ENERGY STAR-related activities described in Section B below. Applicants must provide at least one supporting material for at least one activity in Section B. (required) When possible, please consolidate supporting materials into one electronic file. Any materials submitted may be used by EPA in promotion of the ENERGY STAR program and will not be returned to applicants.
- PART 4: Organization's high-resolution logo (required)

<sup>&</sup>lt;sup>1</sup> Applicants should make their best estimate of the expected number of homes to be verified for ENERGY STAR certification during calendar year 2018. EPA will confirm the final actual number of reported homes prior to selecting award winners.




## **Important Point for Submittal**

Be ready to submit when you enter the process or be prepared to start again.





The system cannot accept a file larger than 100 MB in size. EPA strongly discourages the use of zip files. Consider splitting larger files into separate smaller

File names must be no longer than 15 characters and contain no spaces or special characters. EPA recommends intuitive file names such as a reference to the organization name, an acronym, or and the content of the file (e.g., EPAenergyEd).

Where possible please consolidate your supporting materials into one or two PDF files. For example, a PDF file could be compiled that labels items by type (e.g., print advertisement, web banner) and subsequently provides supporting imagery under each category

For audio and video examples, it may be best to provide a document containing a screen shot with links to online versions if available

To ensure that your logo is of the highest quality if we use it for print materials, we ask that you submit a logo file in one of the following vector\* formats:

SVG - Scalable Vector Graphic

EPS - Encapsulated PostScript

PDF - Portable Document Format (vector not raster)

What does "vector" mean, exactly? There are two types of electronic image files: (1) raster graphics (jpeg, gif, bmp, tif ) in which several individual pixels together form an image And (2) vector graphics which are constructed using geometric elements and mathematical formulas. The benefit of vector graphics is that, unlike raster graphics, they can be scaled to any size without losing quality.

## The Upload Page - have all four documents ready!

You will submit 4 documents

- 1) Executive Summary
- 2) Accomplishments Narrative
- 3) Supporting Materials (limit of 100 MB)
- 4) High Resolution Logo (SVG, EPS or PDF)

You are required to submit something for all 4 categories. The application will not be accepted with out an attachment for each category.



## Pro Tip 2

• Put all your supporting materials into a pdf. Provide links to large files and web pages to avoid bumping up against file size limits.




