




ENERGY STAR Residential New Construction Programs: Past



Checklist Item/Prerequisite Summary

Mandatory Features Leatnes Mandatorh

- Developed by evaluating req'ts from Single-Family & MFHR and combining/adjusting as appropriate (both more and less stringent)
- Similar Checklist format as Single-Family
- Added req'ts for central HVAC & HW systems
- Added req'ts in common areas
- Added req'ts to reduce hot water energy use


